

# **Kentucky 4-H State Shooting Sports Education Program Rules**

Updated 11/6/2024 – updates HIGHLIGHTED

By entry in the KY 4-H Shooting Sports State Competition the county 4-H Agent verifies that those youth entered are enrolled members of the KY 4-H program in their respective counties, knowledgeable and proficient in the safe use of the equipment, and knowledgeable of the general rules of the event. Event and/or range officials may dismiss or disqualify any participant if they believe the participant does not demonstrate the basic proficiency and knowledge required. Violation of any of these policies and/or rules are grounds for disqualification and dismissal from the KY 4-H Shooting Sports State Competition.

Any KY 4-H Shooting Sports State Competition rule will supersede all National Association Rules, but where no 4-H rule has been established, National Rules of the respective shooting sports association will apply. These include:

- NRA Smallbore Rule Book all rifle (except BB) and pistol disciplines .
- NRA BB Gun Rule Book BB rifle •
- Amateur Trap Association Rules trap •
- National Muzzleloading Association Rules all muzzleloading disciplines •
- National Field Archery Association Rules all archery disciplines •

## SYNOPSIS OF GENERAL RULES/GUIDELINES

### **Participation**

- 1. 4-H Membership All 4-H members participating in the KY 4-H Shooting Sports State Competition must be officially enrolled through 4-H Online in their county 4-H Shooting Sports program and have completed 6 hours of education prior to the event.
- 2. Age Requirement Participants must be 4-H age (age as of Jan. 1<sup>st</sup> of the current year) 9 to 18 to compete at the KY 4-H Shooting Sports State Competition. Competitors will be divided into three age categories for the event, 9-11, 12-14, and 15-18.
- 3. Individual Participation All participants will be entered as individuals in all events and will be competing for individual awards and recognition.
- Team Composition County teams will be composed of the 4 highest scoring individual competitors from a 4. county in each age division for all events EXCEPT for shotgun which will be composed of the 5 highest scoring individual competitors, and muzzleloading (flintlock rifle), and muzzleloading (pistol) which will be composed of the 3 highest scoring individual competitors in each age division.
- 5. Event Participation An individual may participate in no more than three events on Day 1 (Saturday) of competition and one event on Day 2 (Sunday).
- 6. Event Registration All county registrations must be submitted online by the deadline specified by the KY 4-H Shooting Sports/Camping Specialist Associate in that given year. Registration can only be submitted by a county Agent or Extension Staff member.
  - a. A 2-week review period will follow the close of event registration. During this time counties are permitted changes, substitutions, and additions to their county registration. No changes will be accepted

after the review period has ended.

- 7. **Event Payment** All registration fees are due by the deadline specified by the KY 4-H Shooting Sports/Camping Specialist Associate in that given year. All registration fees must be paid in full prior to the event date.
- 8. **Cancellations** Any cancellations received prior to the registration deadline will be refunded with a 5% processing fee. No refunds will be given after the deadline.
- 9. Volunteer Requirement Every county participating in the KY 4-H Shooting Sports State Competition is required to provide 1 (one) volunteer for every four (4) registered participants, or portion thereof, per day of competition. Volunteer sign-ups must be completed by the deadline specified by the KY 4-H Shooting Sports/Camping Specialist Associate in that given year. A county who does not meet the volunteer requirement is subject to disqualification from the State Competition the following year.

### **Conduct**

- 4-H Image and Honor The KY 4-H Shooting Sports State Competition is a youth event showcasing the discipline and hard work of 4-H members from across the state. The scope of this event demands that all involved from the young people participating to the State Coordinator, range officials, volunteers, coaches, and parents put forward the best image of the KY 4-H Shooting Sports Program and KY 4-H program. The use of alcoholic beverages and any use of tobacco products and/or e-cigarettes/vapor cigarettes by youth participants is strictly prohibited. Violation of this policy is grounds for disqualification and removal from the KY 4-H Shooting Sports State Competition.
- 2. Knowledge of Rules and Procedures All events in this competition have a set of rules provided in this document. Where no KY 4-H Shooting Sports event rule exists the denoted corresponding National Governing Body (NGB) rules will be followed. Participants and coaches are responsible for reading the rules, understanding the procedures for each event, and complying with the rules and standards involved. Questions are encouraged to clarify areas of confusion or misunderstanding. Ignorance of the rules is not an excuse for not following them. Participants are responsible for knowing the rules of their events and complying with them. Learning the rules is part of the educational process for shooting sports participants.
- 3. **Dress Code** Participants and coaches are expected to dress appropriately for the events in which they are taking part in. Team uniforms or shirts are encouraged, but not required. Both youth and adults should wear attire appropriate for the weather while remaining modest. Specific guidelines include:
  - a. Shorts should be a modest length. A good length is about mid-thigh. No cut-off shorts permitted.
  - b. All shirts must have sleeves. Spaghetti straps, muscle shirts, bare midriffs, low necklines, or otherwise revealing clothing will not be allowed.
  - c. No clothing with alcohol, tobacco, vulgar language, or sexual reference will be permitted.

If a violation is found, the individual will have the opportunity to correct the issue before further action is taken.

- Footwear Policy Participants are required to wear shoes that completely cover the foot, including soles, during all events. Examples of footwear that are NOT acceptable include sandals, clogs, Croc<sup>™</sup> style shoes, slippers, house shoes, flip-flops and bare feet.
- 5. **Behavior and Sportsmanship** All participants, coaches, and spectators will demonstrate the highest levels of sportsmanship, supporting the objectives and ideals promoted by the 4-H program in general and the KY 4-H Shooting Sports Program in particular. All participants, coaches, and spectators are expected

to conform to the KY 4-H Code of Conduct, not only to the letter, but in its intent. Anyone found to be behaving in any way not in accordance with the Code of Conduct or the rules/policies outlined in this document is subject to immediate disqualification and/or ejection from the event.

### **Range Protocols**

- 1. There will be no open practicing before or after the event.
- 2. All ranges will be set-up in the interest of safety and practicality.
- 3. Participants and County Level I Instructors are required to wear a current State Competition identification badge (templates provided) during the event. Badges must be visible to range officers and volunteers.
- 4. Check-in Procedures:
  - a. Saturday All participants must check in at their ranges no later than 11:00am ET and all ranges will close at 2:00pm ET. At the time of range closure, if a participant has checked in but is not present at the range when their name is called, they will be disqualified from that event.
    - i. .22 Target Rifle youth competing in this event must be checked in at the range by 7:30am ET. They will be the first relay(s) placed on the line at 8:00am ET.
  - b. **Sunday** Participants will be assigned to squads. The first round of squads will begin at 8:00am ET. Each consecutive squad will begin immediately after the previous squad has finished. Range instructions and equipment inspection will begin prior to the start of the next assigned squad and before the completion of the current squad on the line. It is the responsibility of the competitor to know their assigned range, squad #, and be present in advance of their turn. Any participant not present at the range when their name is called will be disqualified.
- 5. **Target/Scorecard Labels** all disciplines (except shotgun) will require competitors to place printed labels or write legibly the below information on the back of all their target(s)/scorecard(s). Any target/scorecard missing this information will be disqualified.
  - Target/Scorecard Label Information:
    - i. Name
    - ii. Age Group
    - iii. County
    - iv. Registration Number
    - v. Position (if applicable)
- 6. Equipment counties/individuals are responsible for providing all necessary equipment, including but not limited to firearms, bows, ammunition, arrows, eye protection, ear protection, etc. All equipment used in competition must meet specifications for that discipline and event as outlined in this document.
- 7. All firearms and bows will remain cased until the competitor has arrived on the range and been instructed to uncase their equipment by the Range Officer. Arrows must be carried in a quiver or other suitable container. Holsters are not acceptable cases.
- 8. All firearms will be unloaded at all times with action open until the command to "LOAD" is given by the Range Officer.
  - a. The use of Clear Barrel Indicators (CBIs) made of fluorescent orange (recommended color) or a similar bright colored material and long enough to visibly protrude from both the breech and muzzle when

inserted in the bores is mandatory in all .177 and .22 caliber rifles and pistols where possible.

- b. CBIs shall be inserted before a rifle or pistol is brought to the range or when it is removed from a gun case on the range under the supervision of the range officer.
- c. CBIs may only be removed during preparation, firing and change-over periods. When a stage of fire is completed, a CBI must be inserted and the firearm must be grounded. CBIs must remain inserted after cleared firearms are removed from the firing line and as long as the firearm remains on the range. CBIs may be removed when firearms are replaced in gun cases.
- 9. The Range Officer shall have the authority to inspect any firearm, bow or equipment prior to, or during competition, for compliance with equipment requirements as well as for safety. Any equipment found to be out of compliance or unsafe will be removed from the line immediately. Competitors will have an opportunity to fix the identified issue or get replacement equipment and may return to the line prior to the closing of the range.
- 10. Pets will not be permitted on the grounds of 4-H Shooting Sports Education events except those under leash control of the owner. Any pet running free will be impounded and removed from the grounds.

## Health & Safety

- 1. **Medical Consent Form and Adult Supervision** it is the responsibility of the county to have the appropriate health and release forms on hand or on file for each participant. A parent/guardian or designated chaperone must be present with each participant during the event in case of emergency.
- 2. Safety Safety is the first priority of all range staff, participants, coaches and spectators. Standard and accepted range and shooting safety rules will always be followed. Any site-specific safety considerations will be announced at the appropriate venues. The KY 4-H Shooting Sports/Camping Specialist Associate, Range Officers, or other event staff may caution, warn, or remove any person on any range for unsafe behavior. Such removal may result in forfeited scores, disqualification, or removal from the grounds. Any spectator contributing to unsafe behavior or rules violations may be barred from the ranges by the KY 4-H Shooting Sports/Camping Specialist Associate, Range Officers, or other event staff at any level.
- 3. Cell Phones and Other Electronic Devices
  - a. Except in emergency situations, NO cell phones, radios, ear buds, smart watches, or other electronic communication devices may be used by competitors or others on or in the immediate vicinity of the ranges during active competition.
  - b. Essential communication may take place off the ranges where the process will not interfere with competitors or compromise safe operation of the range.
  - c. No hand-held radio communications will be allowed except for State Competition officials.
- 4. Eye and Ear Protection Requirement
  - a. **Eye Protection:** Adequate eye protection (shooting glasses, safety glasses/goggles or polycarbonate prescription glasses) are required for all competitors. Range officers and volunteers on or near firing lines are subject to the same requirement. Eye protection is recommended for archery.

b. **Ear Protection:** Ear protection is required for competitors within the muzzleloading, .22 pistol, .22 rifle and shotgun disciplines. Range officers and volunteers on or near firing lines are subject to the same requirement. Ear protection is recommended for air rifle and air pistol.

### **Reasonable Accommodation**

1. To request any accommodation to participate in the State Competition, the county 4-H Agent MUST contact the KY 4-H Shooting Sports/Camping Specialist Associate by the specified deadline shared prior to the event and submit a Request for Accommodation Form.

### Coaching

- 1. **Coaches** All Certified Level I Instructors should have a State Competition ID Badge (template provided) during the event. Badges must be visible to range officers and volunteers.
- 2. Coaching Coaching is not permitted during the State Competition once competitors have moved to the firing line. Coaches and parents/guardians may not create a disturbance, upset either their competitors or others, create unnecessary delays, or otherwise interfere with the safe and efficient operation of the range. Unless called to the line by Range Officers, coaches/parents/guardians will remain in the designated spectator's area. Coaches/parents/guardians may NOT initiate contact with their competitors. Spotting devices may be used to observe shot placement but may not be used to coach any competitor on the firing line.
  - a. Assistance is permitted on the firing line for competitors in BB, Air Rifle and Air Pistol as need and if an accommodation has been requested.

#### **Challenges and Protests**

- Challenges Only competitors may review their targets and challenge scoring. The challenge period will begin when the score is entered at the clubhouse and will end 20 minutes after that disciplines range has completed for the day. Shotgun competitors have 15 minutes to challenge their score after the final scores are posted and/or announced. Upon competition of that time period, the right to challenge expires, and scores will be deemed correct as posted.
- 2. Challenge Fees Any challenge must be accompanied by a fee of \$1 per target challenged. Serial challenges (following one challenge with another) are permitted, but once the competitor has reviewed and either challenged or accepted their scores, the right of review terminates. A jury (not including the original scorer) will review each challenge and render judgement to the challenger. No fee is required to point out mathematical errors or similar mechanical problems.
- 3. Official Protests Youth participants only, or with the support of their Certified Level I Instructor, may protest:
  - a. An injustice they feel has been done to them individually
  - b. Breaking of KY 4-H Shooting Sports Rules and Policies or discipline specific rules
  - c. Crossfires, incorrect calling of hit/miss, or any other specific scoring occurrence on the firing line.
- 4. Steps to Filling an Official Protest Only competitors affected can make the protest and they must be

initiated immediately upon the occurrence of the protested incident.

- a. State the complaint verbally to the Range Officer. If the complaint is not satisfied with the decision of the Range Officer, then:
- b. Appeal the decision to the KY 4-H Shooting Sports/Camping Specialist Associate within 30 minutes of the Range Officers decision. The KY 4-H Shooting Sports/Camping Specialist Associate will then assemble a Grievance Committee of at least 5 individuals, composed of themselves, Level II Instructors and 4-H Agents.
  - i. It is the responsibility of the Grievance Committee to interpret and apply the rules and resolve protests. Members may not rule on a matter in which they or their team are personally involved. Decisions by the Grievance Committee must be based on applicable rules or, in cases not specifically covered by the rules, must be governed by the intent and spirit of the rules. The committee may also hear verbal explanations from both the Range Officer and the person making the appeal. No committee decision may be made that is contrary to the Rules. Protests must be decided by a majority of the committee.
  - ii. Findings of the State Competition Grievance Committee are final.

### Scoring & Ties

- 1. Scores posted after the conclusion of the final challenge period are final.
- 2. Individual and Team ties will be broken in accordance with the discipline specific guidelines provided in this document. Where ties still exist after following those guidelines the National Rules of the respective shooting sports association shall be referenced.
  - a. In the case of an individual/team shoot-off, all original members must be present and participate in the shoot-off or they will forfeit their placing.
- 3. Awards will be given for:
  - a. Top three individual competitors in each age division in each discipline
  - b. Top three teams in each age division in each discipline

## DISCIPLINE SPECIFIC RULES

### ARCHERY

- Archery will consist of 5 separate divisions:
  - o Bowhunter
  - o Target Compound
  - Target Recurve
  - Compound Bare Bow
  - Bare Recurve/Long Bow
- The NFAA Whistle System will be used during competition.
  - <u>Upon two blasts of the whistle</u>: the participant will straddle the shooting line with the lower limb of the bow resting on the toe of the foot closest to the target. No arrows are to be removed from the quiver until one blast is made at which the participants shoot the five arrow end. After shooting, each participant will move back from the shooting line indicating they have completed that end.
  - <u>Upon three blasts of the whistle</u>: the participant is to move to their target but cannot remove their arrows until told to do so by an official scorer.
  - <u>Upon four or more blasts of the whistle</u>: there is a dangerous situation on the range and all participants are to quiver all remaining arrows immediately and step back from the shooting line. If at any time a participant sees a situation that they deem dangerous, they may yell "CEASE FIRE!" Then the range officer will give four blasts of the whistle. The participant may also raise their bow in the air to signal the range officer if they need help on the line.


